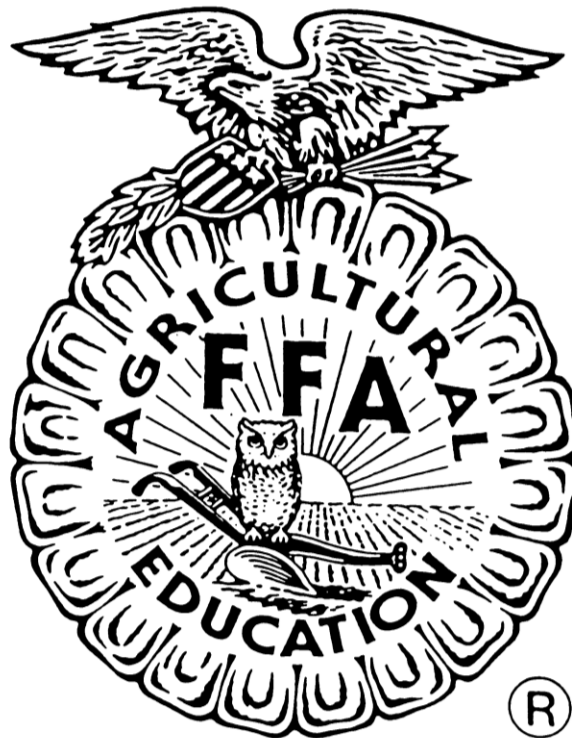

CREED SPEAKING LEADERSHIP DEVELOPMENT EVENT

PURPOSE

The Creed Speaking Leadership Development Event is designed to develop agricultural leadership by providing FFA members in Grades 7-9 an opportunity to participate in a leadership development activity.

ELIGIBILITY AND REGULATIONS

Participation is limited to dues paying FFA members in Grades 7-9.

An elimination event at the county level must be held to determine the county winner. Only the winner from each county is eligible to participate in the area and/or the district events. If only one chapter has an entry, this participant is automatically the county winner, thus no need for a county event to be held.

The first and second place winners in the North, Central and South Districts will compete in the state finals.

EVENT RULES

1. The Creed Speaking Leadership Development Event is limited to dues paying FFA members in Grades 7-9.
2. Participants shall be in (FFA) official dress as defined in the *Official FFA Manual*.
3. Three competent and impartial persons will be selected to judge the event. At least one judge should have an agricultural/FFA background.
4. A timekeeper will keep time for each participant and inform the judges of any penalty points to be deducted from a participant's score.
5. An accuracy judge will score each participant on the accuracy of their delivery of the FFA Creed. The accuracy judge will keep track of recitation errors, which are defined as the substitution, repetition, addition and/or omission of a word. For each recitation error there will be a 20 point deduction. Errors are considered on a per word basis. If a student gets "stuck" during their delivery for longer than 15 seconds, the accuracy judge will give them a one word prompt for the point deduction of missing a word.

6. Each participant shall be asked the same questions. There will be no two part questions asked during the competition. **Opinion questions should be scored on the method of delivery.**
7. The participants will draw for the order of presenting at the beginning of the event.
8. If a cell phone is seen or heard in the possession of a competitor, that individual competitor will be disqualified from competition and receive a score of zero.
9. Time begins when time keeper announces, "Time begins..." (Participant must wait for time keeper's announcement before beginning speech.)

EVENT FORMAT

1. The event will include both an oral presentation as well as answering questions directly related to the FFA Creed. Each contestant will be asked three questions, with a five minute time limit. The questions will be formulated annually by the Creed Speaking Leadership Development Event committee and will avoid two part questions. Sample questions are provided on the forms and applications page of www.alabamaffa.org
2. Members will present the FFA Creed from the current year's Official FFA manual.
3. The event will be a timed activity with four minutes for presentation. After four minutes, the contestant will be deducted 1 point for every second over four minutes.
4. Each contestant must recite the FFA Creed from memory. Each contestant shall begin the presentation by stating "The FFA Creed by E.M. Tiffany." Each contestant shall end the presentation with the statement "... that inspiring task. Thank you."
5. Contestants will be held in isolation until their presentation. Contestants will not be allowed to have contact from any outside persons **until their recitation is complete. Speakers will not hear each other's speech. Only members or representatives (parents and/or advisor) of the speaker's chapter will be allowed to observe. Contest officials reserve the right to ask anyone whom is a distraction to the speaker to leave.**
6. At the time of the event, the judges will be seated in different sections of the room in which the event is held. They will score each participant on the delivery of the Creed, using the score sheet provided.
7. A timekeeper shall be designated who will record the time used by each participant in delivering his/her speech.
8. An accuracy judge will record the number of recitation errors during delivery.
9. When participants have finished speaking each judge will total the score of each speaker. The timekeeper's and accuracy judge's records will be used in computing the final score for each participant. The judges' score sheets will then be submitted to event officials to determine final ratings of participants.

10. Participants shall be ranked in numerical order on the basis of the final score to be determined by each judge without consultation. The judges' ranking of each participant then shall be added, and the winner will be that participant whose total ranking is the lowest (low point score method of selection).

TIEBREAKERS

Ties will be broken based on the greatest number of low ranks. Participant's low ranks will be counted and the participant with the greatest number of low ranks will be declared the winner. If a tie still exists, then the person in charge of the event will rank the participant's response to questions. The participant with the greatest number of low ranks from the response to questions will be declared the winner. If a tie still exists then the participant's raw scores will be totaled. The participant with the greatest total of raw points will be declared the winner.

OFFICIAL DRESS

Male Members

Black slacks, white collared shirt, official FFA tie, black socks, black dress shoes, and the official jacket zipped to the top. Bow ties are not considered official dress.

Female Members

Black skirt, white collared blouse with official FFA blue scarf, black nylon hosiery, black dress shoes with a closed heel and toe, and the official jacket zipped to the top.

SUMMARY SHEET

When all participant have finished, the judges will retire and make their placings (1, 2, 3, etc.) without any discussion. The judges' rankings of each participant then shall be added, and the winner will be the participant whose total ranking (score) is the lowest. This is the low point score method of selection.

The person in charge will assist by recording the final placings of each judge on the Summary Sheet to determine the winners. In case of a tie, ties will be broken based on the greatest number of low ranks. Participants' low rankings will be counted and the participant with the greatest number of low rankings will be declared the winner. If a tie still exists, then the person in charge of the event will rank the participant's response to questions. The participant with the greatest number of low ranks from the response to questions will be declared the winner. If a tie still exists, then the participant's raw scores will be totaled. The participant with the greatest total of raw points will be declared the winner.

The Summary Sheet should be checked and double-checked before the winners are announced. The decision announced is final! The individual score sheets should be destroyed immediately by the judges; no one else will be allowed to see the score sheets.
